Following this issue, the Company has the ability to issue 13,839,921 ordinary shares under its block listing facility. As a result of this allotment, the total number of ordinary shares in issue now stands at 143,254,887.

Shareholders may use the figure 144,432,887 as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change to their interest in, the Company under the FCA's Disclosure and Transparency Rules.
